STATEMENT OF UNDERSTANDING

AGREEMENT between The Junior League of Lynchburg, Inc. ("Junior League") and

RECITAL: Participant desires to participate in The Day in the Park and to conduct the following activity:

On the date and time(s) of September 11, 2010 from 10:00am to 3:00pm in Miller Park.

Junior League hereby accepts Participant's application and will include Participant in The Day in the Park activities on the following terms and conditions:

1. Participant shall be responsible for the conduct of the above-described activity. Junior League shall not be obligated for any debt incurred because of the Participant's activity in Day in the Park.
2. Participant shall indemnify and save harmless and provide a defense for Junior League, its agents, employees, and officials from any and all liability, of whatever nature, arising from the above-described activity. Participant shall, upon the request of the Junior League, maintain and pay for public liability insurance, naming the Junior League of Lynchburg, Inc. as an insured party, to cover bodily injury per person, bodily injury per accident and property damage in the amount not less than \$300,000 combined single limit to cover injuries to or death of person, or damage of property in connection with the above-described activity. Participant shall upon request provide proof of insurance to the Junior League.
3. Junior League reserves the right to select all events and to refuse participation to any organization or group whose program is determined solely within the discretion of the Junior League to be not in accord with the purposes or the best interests of Day in the Park. The sale of food, novelties and the like are permitted only if approved by the Junior League.
4. The Junior League will not give refunds due to inclement weather.
