Junior League hereby accepts Participant's application and will include Participant in All Aboard activities on the following terms and conditions:

1. The All Aboard Application for Participation, Signed Participation Guidelines, and Certificate of Liability Insurance must be received prior to the event in order to participate.
2. Vehicle space assignments will be determined by the Junior League of Lynchburg based upon the best interests of the event basis. Vehicles will be located on the open blacktop.
3. Vehicle participants acknowledge that a **minimum of one adult representative must be present during the event to supervise the Vehicle(s) between the hours of 10:30 a.m. to 4:00 p.m. on Saturday, April 17th, 2021.** Vehicle representative should be able to provide a narrative description of the Vehicle(s)'s specifications and/or services as well as facilitate guided "tours" of the Vehicle(s)'s interior as allowable by the Vehicle's size.
4. Vehicle sponsors acknowledge that the nature of the All Aboard event involves the interaction of children with Sponsor's vehicle(s) so that the children are able to touch, see and explore the vehicle(s) and learn about the vehicle(s)'s function. The Junior League will take appropriate measures to facilitate a safe event; however, the sponsor remains responsible for the supervision and safety of its vehicle(s). The sponsor shall indemnify, save and hold harmless the Junior League of Lynchburg and its officers, directors, and volunteers from all liability, damage, loss, claims, costs, demands and actions of any nature whatsoever arising out of the All Aboard event.
5. Vehicle participants must arrive on event day at a predetermined time by the Junior League of Lynchburg to set-up. Vehicles requiring special accommodations, such as a large turning radius, will be asked to arrive early during event set-up. **Vehicles are expected to stay the entire length of the event and may not leave until the event's conclusion at 4:00 p.m.** unless otherwise agreed to in advance by the Junior League of Lynchburg. The Junior League of Lynchburg will contact participants with exact times as the event approaches.
6. Sponsors may bring banners, signage, decorations, etc. to promote their business. The Junior League of Lynchburg shall not be held responsible for any loss or damage to vendor property.
7. Sponsor acknowledges that wireless internet access is not available at the event venue. Air cards from mobile carriers should work but service is not guaranteed by the Junior League of Lynchburg.
8. The sponsor grants permission to the Junior League of Lynchburg to take photographs or record videos of vendor and/or display during the event for the strict purpose of promotion and publicity of the event and/or the Junior League of Lynchburg.
9. Sponsor and their representatives shall conduct themselves in a manner that is appropriate for the family-oriented event, which includes but is not limited to no smoking, no profanity, and no display of inappropriate content or clothing. By their signature hereto, the parties acknowledge they shall be bound by this Agreement and it has been executed pursuant to due authority.
10. We will be following CDC guidelines including mask requirements and social-distancing to ensure that we are taking every precaution possible to protect our community so that a "wheelie" good time is had by all!
